- 2. The complete description viz. make and model of the Battery and name of the manufacturer must be clearly indicated. NIT Jalandhar reserved the right to place order on CIF or FOB basis. Batteries should also be insured upto NIT Jalandhar.
- 3. The items which can/are to be procured indigenously may be listed separately.
- 4. The institute being government educational institute is having Excise and Custom duty exemption in terms of government notification No. 51/96-customs Dt. 23-7-1996 and No. 10/97-central excise Dt. 1-3- 1997 as amended from time to time, therefore taxes be quoted accordingly and this must be depicted Price Bid clearly.
- 5. The rate should be quoted excluding Excise/Custom Duty. The tenders claiming Excise / Custom Duty as extra should specifically give the present rate of Excise / Custom Duty as payable against each Battery.
- 6. GST/VAT/ Central Sales Tax/inter State Tax or any other chargeable duty where applicable must be specifically mentioned, failing which no tax or duty will be allowed at subsequent stage.
