How to apply: The link to fill the online application form can be accessed through Institute website www.nitj.ac.in. Please submit separate application forms, if applying for more than one programme. An Application Fee of Rs.1000/- (Rs.500/- for SC/ST/PWD candidates) is required to be paid online. The candidates are required to apply online and there is no requirement to send the Hard Copy of the application form to the Institute. Application fee shall not be refunded in any case. Incomplete applications, applications without requisite fee, and applications received after due date will not be considered for admissions.

Last date for submission of online application form is 25.07.2022.

A) MBA (Self-Sponsored) Programme:

Seats Admission to full time Two-year Master of Business Administration (MBA) Programme is on All India Basis Total Seats: 38 (General: 15, OBC: 10, SC: 06, ST: 03, EWS: 04). Horizontal Reservation of 5% to PwD candidates in each category (General, OBC, EWS, SC, and ST) shall be applicable. Candidates applying in categories other than General shall have to provide documents in strict compliance to the stipulations of Govt. of India. Fee structure of self-sponsored seats available on Institute's website.

B) Eligibility Criteria :

The candidate must have bachelor's degree in any stream with 60% marks for General/OBC/EWS candidates and 55% for SC/ST/PwD candidates or equivalent CGPA (more than or equal to 6.5 CGPA for General/OBC/EWS candidates and 6 GPA for SC/ST/PH candidates). Only primary mode of evaluation (CGPA or percentage) as mentioned in the qualifying degree certificate/mark sheet will be considered while verifying eligibility. Conversion from CGPA to percentage or vice versa given by individual Institute/university will not be allowed.

C) Admission Procedure

- (a) The Shortlisted candidates with CAT/GMAT/CMAT/MAT score will directly appear for Group Discussion (GD) and Personal Interview (PI). In case the seats remain vacant through CAT/GMAT/CMAT/MAT score then the institute will conduct its own test for filling up the seats followed by Group Discussion and Personal Interview. Hence, candidates without CAT/GMAT/CMAT/MAT score can also apply.
- (b) Admissions will be made on the basis of CAT/GMAT/CMAT/MAT/Institute test (70% weightage), Group Discussion (15% weightage), and Interview (15% weightage). The weightage for the percentile for CAT/GMAT/CMAT/MAT is given below:

Selection Procedure:

Admissions will be made on the basis of CAT/GMAT/CMAT/MAT/Institute test (70% weightage), Group Discussion (15% weightage), and Interview (15% weightage). The weightage for the percentile for CAT/GMAT/CMAT/MAT is given below

D) Other Issues

- i. Category (General/OBC/SC/ST/PWD/Economically Weaker Section (EWS)) once chosen by the applicant in his/her application form shall not be changed at a later stage. Candidate(s) claiming any reservation category (OBC/SC/ST/PWD/EWS) and General category, should apply on separate application forms for the purpose.
- ii. OBC/EWS Certificate must have been issued on or after **01st April, 2022** so that the candidates from creamy layer are identified. No certificate issued before this date shall be acceptable.
- iii. Submission of Result of Qualifying Examination and other documents: For candidates whose result of qualifying examination is awaited, they shall be given provisional admission after an undertaking that they shall submit the result up to **30th September 2022**, failing which their admission shall automatically stand cancelled (**Annexure-1**).
- iv. Certificate Checking: The certificates (in original) of all the candidates recommended for admission shall be checked by the Department.
- v. The candidate (in service) applying for above mentioned programmes need to apply through proper channel. Any application without "No Objection Certificate" from the employer shall not be considered for shortlisting.
- vi. The application without application fee as applicable/self-attested copies of documents/certificates/testimonials shall be rejected and shall not be considered for shortlisting.

E) Reservation

The reservation rules will be followed as per Government of India guidelines prevailing at the time of admission, at the Institute level.
