- 1 Copy of application form (optional)
- 2 Qualifying Degree/provisional degree certificate
- 3 DMCs bearing grand total of marks, percentage or CGPA\*
- 4 Category Certificate\*
- 5 Certificate of Matriculation bearing Date of Birth\*
- 6 10+2 Certificate\*
- 7 Character Certificate from Institute last attended
- 8 Medical Fitness Certificate
- 9 Migration Certificate
- 10 Annexure A\* (wherever applicable)

\*Essentially required

If candidates have yet to obtain updated category certificate due to lockdown in their respective districts, they should provide the status of their applications.

If qualifying degree has been obtained through Distance Education Mode, a certificate of its recognition from appropriate body will be required.

EWS and OBC certificate must have been issued on or after 01.04.2020 and strictly as per Govt of India format. NCL must accompany OBC certificate.

The candidates who have yet to appear in final year examinations of qualifying degree for the reason of postponement due to COVID 19 should give undertaking as at Annexure A.
