

B. Deposition of Institute Fee:

1. Online Payment of semester fee can be made by using link providing on the Institute website.
2. Payment through Demand Draft/ Internet transfer **directly to Institute account WILL NOT BE ENTERTAINED** by the Account Branch for the students who are not availing any kind of Education loan.

Special Note: Deposit of cash will not be considered as semester fee in any bank of NIT Campus, Fee counter of HDFC/ICICI / IDFC bank. ONLY ONLINE MODE FEES WILL BE ACCEPTED.

C. Instructions for the Students only availing Education loan is as under:

1. Students studying with education loan are advised to ensure that their loans are arranged from funding agencies/Banks well in time i.e. on or before the Registration schedule January-2020. No request for extension of date for fee payment will be accepted in such cases under any circumstances.


