Important points:

1. All the candidates admitted under **SC/ST/OBC** category will have to produce the category certificate in original at the time of admission and registration. **OBC** Certificate should be issued on or after **April 01, 2019** in the appropriate format.
2. The Certificates/documents of all the candidates recommended for provisional admission shall be checked by the individual Department before deposition of fee by the candidates.
3. The candidates whose result of qualifying examination is awaited shall be given provisional admission after an undertaking that they shall submit the result **upto 30th January 2020**, failing which their admission will automatically stand cancelled and no request for further extension will be entertained.
4. Very limited Hostel facility/Transit accommodation is available for PhD students. The admitted students are required to make their stay arrangement themselves if no accommodation is available in the Campus
