Sir/Madam,

As you are aware, the Department of Social Justice and Empowerment is implementing a Central Sector Scheme of 'Free Coaching for SC and OBC Students' to provide coaching of good quality for eligible SC and OBC candidates. The scheme aims at enabling them to prepare for appearing in competitive examinations for obtaining entry into institutes of excellence or for appropriate jobs.

The scheme is implemented in two modes namely, Mode1 and Mode2. Under Mode 1, the scheme is implemented through the empanelled institutes under the scheme. Under Mode 2, the candidates are selected directly by the department as per the criteria prescribed in the scheme guidelines. Under Mode 2 candidates have the liberty to choose any institute of their own choice for pursuing coaching. At present applications have been invited under Mode 2 of this scheme through Portal coaching.dosje.gov.in. **A poster indicating salient features of the scheme, last date of closing the portal etc. is enclosed.**

2. In view of the above context, you are requested to widely publicize the mode 2 of the scheme among the prospective beneficiary students. You are further requested that the poster may be reproduced in shape of banners, A4 size printouts, poster etc. and are displayed at most visited places of the institute premises including entrance of the institution and the hostel, notice board, website etc. Further, the existing beneficiaries of the scheme in higher classes who want to pursue coaching for competitive examinations be also motivated to avail the benefits of the scheme.

3. Such measures and wider publicity of the scheme provisions will attract prospective beneficiary students to utilize the provisions of the scheme optimally.
